The Power Purchase Agreement (PPA) with MSEDCL shall be executed within a period of 15 (fifteen) days from the date of this LOA. The PPA shall be signed only upon receipt of the Performance Bank Guarantee with the validity period of 24 (twenty-four) months from date of issuance of this LOA.

The applicable tariff (3.08 tariff per unit) payable shall be fixed for 25 (twenty-five) years from the Scheduled Commercial Operation Date, as per Letter of Award. The project is expected to cumulative energy generation over period of 25 years is 4,51,687,500 units(approximately estimated amounting of Rs. 13,91,203,660)
